



1. Certification test procedure

The following diagram shows the flow of the Edgecross Recommended Industrial PC certification test from preparation to certification.

2. Conduct before applying for the certification test

Please follow the steps below to take the self-test and then apply for the certification test.

(1) Self-testing

Conduct the certification test in advance based on the certification test specifications. Describe the test results in the certification test result report.

(2) Submit the application documents to the Consortium

Please send the Application Form for the Certification Test and the Certification Test Result Report to the Consortium Secretariat.

3. Certification Test Conduct Methods

The certification test will be conducted by written examination.

The industrial PC vendor will conduct the tests listed in the certification test specifications and submit the test results to the consortium. The consortium will make a certification judgment based on the submitted test results.

5. Conduct after the certification test

After the certification test, please carry out the following according to the instructions of the Consortium Secretariat.

(1) Description and submission of certified product PR information

After the certification test is completed, if there are no problems with the test results, the Consortium Office will send a certification test result report and certified product PR information, so please describe the contents and submit it to the Consortium Office. The certified product PR information refers to the following two items. For details, please refer to "6 Notes on the Certification Test (4)".

- · Excel file for submitting information for publication on the Edgecross Consortium homepage
- · Edgecross Certified Product PR Power Point

(2) Payment of certification test fee

After the result report is sent from the Consortium Office, the Consortium Office will send you an invoice.

Upon receipt of the invoice, please inform the Consortium Office of the date of payment or expected date of payment of the certification test fee. Upon confirmation of payment or intent to pay, a certificate will be issued.

(3) Confirmation of posting of certified products on the website

We will post the submitted information (1) on the Edgecross Consortium website. Please make sure that there are no problems with the content and inform the Consortium Secretariat of the results.

Notes for Certification Test

(1) Method of sending submissions

Please convert the application form for the certification test and the certification test result report into PDF format and send them to the e-mail address below.

(2) Desired date of certificate issuance

The "Desired Date for Issuance of Certificate" on the Certification Test Application Form should be a date that is 5 business days or later from the date of application.

Please note that you may be asked to revise the requested date of certificate issuance if it takes time to correct incomplete submissions.

(3) Certification Test Documents Version

Please make sure to apply for the certification test with the latest versions of the certification test specifications, certification test application form, and certification test result report. The latest version can be downloaded from the members-only web page of the Edgecross Consortium website.

(4) Certified product PR information

The following two documents will be sent to you after the certification test. Please fill out the form and submit it.

■ Excel file for submitting information for publication on the Edgecross Consortium website

This is the file that contains the information to be posted on the Edgecross Consortium website.

A product logo image file must be sent separately from the Excel file.
